


Ageing Well Delivery Plan

- The Life Stage delivery plans are updated every year and represents the joint ambition for the forthcoming year.
- The life stage delivery plans have been updated to take into account all local knowledge regarding priorities for 2023/24 and also include the national priority areas set out in the NHS Planning Guidance and the NHS Long Term Plan.
- The actions within the delivery plans have been shared with partners and then agreed locally across health and social care commissioners.

- Alongside this work providers and commissioners are also working towards the development of one Doncaster plan.
- This will be based on the Place Plan vision, setting out our joint aims for the year and describe how commissioners and the provider alliance will work together.
- The life stage delivery plans will be aligned with the one Doncaster plan.





An Age Friendly Perspective

- Is about adapting a particular 'lens' through which to view policies and services in place
- Focusing attention on the issues of particular relevance to older people and all of us as we age

Becoming an Age Friendly City

The Centre for Ageing Better describe an Age-friendly Community as 'a place where people of all ages are able to live healthy and active later lives. These places make it possible for people to continue to stay living in their homes, participate in the activities that they value, and contribute to their communities, for as long as possible.

<u>The Age-friendly Communities Framework</u> was developed by the World Health Organisation, in consultation with older people. It is built on the evidence of what supports healthy and active ageing in a place.'

Developing a Baseline Assessment

Using available statistical information and insight from the Age Friendly assessment, we will create a baseline profile to assess healthy ageing in Doncaster and build a picture of what it is like to age in Doncaster. This will create a baseline for measuring progress and highlight areas where priority action is needed, influencing strategic priorities, policies and offers of support to promote and embed an Age Friendly approach/culture across the City.

UK Network Registration

People are living longer lives with fewer children which means the population in the UK and in the Y&H region is ageing. As people age they tend to put a greater demand on health and care services.

Additionally COVID-19 has had a disproportionate impact on older people and highlighted the need to focus on this agenda across the system in Y&H.

Ageing Well in Doncaster

Aims and Objectives

- explore more integrated ways of working with our integrated care boards (ICBs), NHS England (NHSE) and ADASS partners



<u>Fuel Poverty – Affordable Warmth Programme</u>

- People at risk of cold homes with a health related condition(s) are eligible for the Boilers on Prescription Service
- There is eligibility criteria
- Majority who access the service are 65+
- Funded through the Better Care Fund (£85,000pa)
- Affordable warmth training (professionals and informal in the community which promotes options available)
- Plan for upcoming financial year is targeted comms and community events for people at risk of fuel poverty

Housing – Ageing Well

The Housing Strategy 2020-25 recognises the importance of homes being accessible and inclusive in their design to meet residents' current and future housing needs. Homes should suit the requirements and support of inhabitants including those with disabilities or long-term conditions and older people allowing them to remain as independent for as long as possible.

Social Prescribing

- 22/23 1627 referrals across Doncaster
- 72% over 50
- 47% 65+
- 307 referrals linked to housing solutions and help to stay living at home
 - Unsuitable housing
 - Very poor living conditions affecting health
 - Adaptations/Aids
 - Difficult system to navigate
 - older people who own property however cannot afford repairs and are now too frail to sell and downsize if they have no family.

Compassionate Approach

Compassionate Conversations about Energy toolkit aimed at supporting professionals visiting households.

The toolkit aims to support professionals to have meaningful conversations with compassion, and provides useful information relating to affordable warmth, energy saving advice and referral pathways.



Stock Condition Survey – Health Impact Assessment

- Poor housing condition (defined as housing where a HHSRS Cat 1 hazard is present) causes an estimated 880 harmful events requiring medical treatment each year in the borough
- Of those 880 events almost all are avoidable and range from respiratory diseases arising from excess cold in homes to fractures and injuries caused by falls
- The est cost to the NHS p.a. arising from poor property condition is £5.5m, and the costs to wider society (other public services, spending on benefits, loss of future earnings etc) is £42m
- The biggest savings achievable on these costs arise from removing/reducing fall hazards for older people
- Doncaster has a higher rate of fall hazards than the England average the most common incident is "falling on stairs"
- Excess cold removing/reducing this hazard would typically involve installing or improving loft insulation to 300mm, installing cavity wall insulation, installing central heating where there is none and having a room thermostat. However, with fuel costs at their current level, perhaps the main challenge from many people is being able to afford to use their central heating system enough to keep a property suitably warm (+16 degrees)

Energy Efficiency

The Council has drawn in more than £6m over the last couple of years to press ahead with retrofitting housing to make big improvements to energy efficiency, with over 1,000 homes being improved. Most of them are St Leger homes because that's where most of the grant funding has been aimed at, but we have also been helping private households.

The housing retrofit challenge is huge in terms of reducing carbon emissions and tackling climate change – well over 100,000 homes across the borough will need improving in the drive to net zero, but those same works also help make sure cold-related illnesses are reduced.


